As of December 31, 2019, Mr. Agarwal beneficially owned (A) 25,000 shares of the Issuer's Class A Common Stock and (B) 7,645,338 shares of the Issuer's Class B Common Stock, consisting of: (i) 1,848,681 shares held directly by him, (ii) 1,873,491 shares held by the Amit Agarwal 2018 GRAT, (iii) 1,950,000 shares held by the Amit Agarwal 2019 GRAT, (iv) 533,166 shares held by Mr. Agarwal's spouse, and (v) 1,440,000 shares issuable pursuant to stock options held by Mr. Agarwal that are exercisable within 60 days of December 31, 2019. The Class B Common Stock is convertible at the holder's option into the Issuer's Class A Common Stock on a 1-for-1 basis. The holders of Class B Common Stock are entitled to ten votes per share and the holders of Class A Common Stock are entitled to one vote per share.

(b) Percent of Class:

Based on (i) 64,308,498 shares of the Issuer's Class A Common Stock and (ii) 232,078,452 shares of the Issuer's Class B Common Stock, in each case, issued and outstanding as of December 31, 2019, as reported by the Issuer, and the information set forth in (a) above, Mr. Agarwal beneficially owned (A) 10.7% of the Issuer's outstanding Class A Common Stock (treating only shares of Class B Common Stock beneficially owned by Mr. Agarwal as converted for purposes of computing this percentage), and (B) 2.6% of the Issuer's outstanding Common Stock, representing 3.2% of the total voting power of the Issuer's outstanding Common Stock.
