**(a) Amount Beneficially Owned:**

As of December 31, 2019, Mr. Lê-Quôc beneficially owned 25,216,164 shares of the Issuer's Class B Common Stock, consisting of: (i) 13,558,395 shares held by the Alexis Lê-Quôc Revocable Trust, (ii) 3,505,569 shares held by the Alexis Lê-Quôc 2016 GRAT, (iii) 600,000 shares held by the Agathe Lê-Quôc 2018 Trust and 600,000 shares held by the Artemis Lê-Quôc 2018 Trust, (iv) 600,000 shares held by the Pomel Descendants' 2018 Trust, for which Mr. Lê-Quôc acts as trustee, and (v) 6,352,200 shares issuable pursuant to stock options held by Mr. Lê-Quôc that are exercisable within 60 days of December 31, 2019. The Class B Common Stock is convertible at the holder's option into the Issuer's Class A Common Stock on a 1-for-1 basis. The holders of Class B Common Stock are entitled to ten votes per share and the holders of Class A Common Stock are entitled to one vote per share.

**(b) Percent of Class:**

Based on (i) 64,308,498 shares of the Issuer's Class A Common Stock and (ii) 232,078,452 shares of the Issuer's Class B Common Stock, in each case, issued and outstanding as of December 31, 2019, as reported by the Issuer, and the information set forth in (a) above, Mr. Lê-Quôc beneficially owned (A) 28.2% of the Issuer's outstanding Class A Common Stock (treating only shares of Class B Common Stock beneficially owned by Mr. Lê-Quôc as converted for purposes of computing this percentage), and (B) 8.3% of the Issuer's outstanding Common Stock, representing 10.3% of the total voting power of the Issuer's outstanding Common Stock.
